## Membership Type and Benefits

### FAMILY

Entitles member, spouse and dependants under age 23 to all club privileges including the opportunity to make tee times seven (7) days in advance.

### SINGLE ADULT

Entitles member to all club privileges including the opportunity to make tee times seven (7) days in advance.

### SOCIAL +25

Entitles holder to 25, 18-hole rounds or 50, 9-hole rounds and all club privileges including the opportunity to make tee times seven (7) days in advance. When the rounds are completed, the holder may pay the difference to upgrade to a full membership. He or she may also purchase a punch card or may pay green fees.

### SOCIAL +18

Entitles holder to 18, 18-hole rounds or 36, 9-hole rounds and all club privileges including the opportunity to make tee times seven (7) days in advance. When the rounds are completed, the holder may pay the difference to upgrade to a full membership. He or she may also purchase a punch card or may pay green fees.

### SINGLE (ages 19-23)

Entitles holder who is between the ages of 19 and 23, on January 1st, to all club privileges and to make tee times two (2) days in advance.

### SOCIAL

Entitles holder to the use of pool, clubhouse, tennis courts and social events. Holders have no golf privileges.

### YOUTH (high school seniors and under)

Entitles high school seniors (2008-2009) and under to club privileges, but with restricted tee times. Youth tee time restrictions will be posted at the beginning of the season.

### GOLF PUNCH CARDS

Entitles holder to 10, 18-hole rounds or 20, 9-hole rounds of golf only. Golf Punch Cards can be used for Golf Carts also.
