



## **Membership Descriptions**

### **Family**

Entitles member, spouse, and dependents under the age of 23 to all club privileges including golf, pool, and driving range. Reciprocal cards are available under this membership. This membership is not transferable.

### **Single Adult**

Entitles members to all club privileges including golf, pool, and driving range. Reciprocal cards are available under this membership. This membership is not transferable.

### **Family Social +20**

Entitles holder to (20) 18 Hole rounds or (40) 9 hole rounds of golf. The membership holder may also use this pass for cart rental in conjunction with used punches for green fees. (One 9 hole punch/person for the round) This membership also includes all club privileges including pool and the driving range. When the rounds are complete on the card, the purchaser may pay the difference and upgrade to a full membership (discounts do not apply). Reciprocal cards are available under this membership. This membership can be used by the purchaser only and is not transferable.

### **Social/Pool**

Entitles holders to the use of the pool and club social events. Holders have no golfing privileges. 19-29 Single Entitles member whose age is from 19 to 29 years of age at the time of purchase to all club privileges including golf, pool, and driving range. Reciprocal cards are available under this membership. This membership is not transferable.

### **Youth (High School seniors and under)**

Entitles member to golf privileges. Range and Reciprocal cards are not included with this membership. This membership is not transferable. Range can be added with the "Youth with Range" membership



### **Golf Punch Cards**

Entitles holder to (10) 18 Hole rounds or (20) 9 Hole rounds of golf only. Punches may be used towards golf cart rental. Reciprocal cards, range, and pool privileges are not included with this membership. This membership is transferable

### **General Cart Lease Information**

Golf cart leases are attached to the primary membership and extend only to individuals included under that membership classification and its approved extensions.

- ☐ Non-members playing with members who hold cart leases are not covered under the lease and remain responsible for applicable cart fees.
- ☐ Members without their own cart lease are still responsible for applicable cart fees, even when playing with a member who holds a cart lease.

### **Family Cart Lease**

A Family Cart Lease covers up to four seats on a golf cart for family members included under the membership only.

### **Single Adult Cart Lease**

A Single Cart Lease covers one seat on a golf cart for the individual member associated with the membership only.

### **Personal Cart Lease**

If you own a personal golf cart, anyone can ride in your cart for free, please have the riding member or guest specify this at Pro Shop check-in, and your riding member or guest will not be charged a cart fee.

**New Gold Carts:** All **NEW** carts coming into cart shed at Shoreland need to be **GAS ONLY**.



## **Frequently Asked Questions – Cart Leases & Course Policies**

### **How do golf cart leases work?**

Golf cart leases are attached to the primary membership and extend only to individuals included under that membership classification and its approved extensions.

### **What does a Single Cart Lease include?**

A Single Cart Lease covers one seat on a golf cart for the individual member associated with the membership only.

### **What does a Family Cart Lease include?**

A Family Cart Lease covers up to four seats on a golf cart for family members included under the membership only.

### **Where do I stand if I have a Personal Golf Cart Trail Fee & Cart Storage?**

If you own a personal golf cart, anyone can ride in your cart for free, please have the riding member or guest specify this at Pro Shop check-in, and your riding member or guest will not be charged a cart fee.

### **Can I use a Shoreland Golf Cart for free if my personal cart is being used and/or not working?**

No. All personal cart users who need to use a Shoreland golf cart pay the appropriate cart fees.

### **Are NON-MEMBERS covered under a member's cart lease?**

No. Non-members playing with members who hold cart leases are not covered under the lease and remain responsible for applicable cart fees.

### **Are MEMBERS without a cart lease covered when playing with a member who has a cart lease?**

No. **Members without their own cart lease are still responsible for applicable cart fees**, even when playing with a member who holds a cart lease.



**Can guests or non-family members use a member's cart lease when the member is not present?**

No. Cart lease privileges apply only to individuals included under the membership and its approved extensions.

**Are fivesomes allowed on the golf course?**

Fivesomes are permitted only on Wednesdays **ALL DAY**. This policy helps maintain pace of play and ensures an enjoyable experience for all members and guests.

**What should I do if I see a fivesome on the course outside of Wednesdays?**

Please report it to the Pro Shop immediately at **507-931-4400**.

**Why are these clarifications being made?**

These clarifications are intended to ensure consistency in cart usage, billing, pace of play, and member privileges across all membership categories.
